Focus on product development progress, while existing business should be doing well

We expect the company to continue doing well on the existing Image Enhancement business and to deliver solid 2Q figures next week. At the same time, we'll be eager to hear more on the product development progress within Digital Pathology. Seeing exciting long-term potential in the stock and downside protection from the existing business, we keep our Buy recommendation at a slightly lower TP of NOK 90/sh (100 previously).

Similar quarter YoY expected; better QoQ

ContextVision (COV) will release its 2Q17 report on August 17th. We expect solid figures with sales of SEK 19.9m, which is up 9% YoY (after weaker 1Q). Adjusted EBITDA (ex. R&D costs) is seen at SEK 5.2m – similar to last year and stronger than SEK 2.8m a quarter ago. Research costs are estimated at SEK 4.9m, on par with the previous several quarters. All in all, EPS should be negative, but adj. EPS, which reflects the existing business development, is expected to come in at SEK 0.39, the same as last year and vs SEK 0.14 in 1Q17.

Focus on product development process within Digital Pathology

There was no news since our last update in early May. Therefore, our focus beyond the figures will be on the progress within Digital Pathology. COV indicated that product development is ongoing and we'll be eager to hear how far the company has come. The aim is for the market entry by end-2018.

Bullish stance maintained, but TP down on USD weakness

We maintain our Buy recommendation on the COV share ahead of the 2Q report. The existing business is expected to continue doing well even if the start of the year did disappoint a bit. At the same time, we see the biggest upside in the long-term strategy of the company to enter the Digital Pathology market that is almost ten times larger than the existing Image Enhancement business. However, we decrease our TP from NOK 100 to NOK 90/sh, as the USD weakened significantly and as Digital Pathology market estimates are based on USD. Still, the TP provides plenty of upside.

To arrive at our share price target we have used a rounded result from our DCF valuation.

Risks

The main risks to our target price on ContextVision are the following:

- Slower sales growth in the operating areas, particularly in the Ultrasound segment;
- Failure to successfully complete R&D and market the new products in the portfolio, i.e. within Digital Pathology field;
- The company invests heavily in R&D and being able to capitalize on these investments, not to incur significant cost overruns etc. in the future is the key for the company's long term growth;
- Currency risk – our long-term estimates for the Digital Pathology market are based on USD, the company reports in SEK and the share is traded in NOK.
